Chairman Randall Crocker asked the public if there were comments at this time. Mark from Congressman Mike Bost's office reported on the Cares Act. The overview is that the federal government is in response to help businesses in the poor economy at this time. And other help for employees and county government for budget short falls.

MEETING

MINUTES OF PREVIOUS Kevin Weston made a motion to accept the minutes of the March 28th Special County Board Meeting Minutes and April 6th Additional County Board Meeting Minutes. Ray Minor seconded the motion. On roll call vote, all voted yes.

TAX ANTICIPATION ORDINANCE

Steve Vercellino, County Treasurer explained that this is an Ordinance Authorizing the Issuance of Tax Anticipation Warrants in Anticipation of Taxes Levied for the General Fund for 2019 in the amount of \$500,000 and he asked the board to pass this ordinance.

Matt Donkin seconded the motion. On roll call vote, all voted yes.

HILL CITY WATER DISTRICT - 1 APPOINTMENT

Chairman Randall Crocker stated that the next item on the agenda is an appointment to the Hill City Water District Board and he recommended Paul Leffler be reappointed for another five year term ending April 30, 2025.

Jack Warren made a motion to reappoint Paul Leffler to the Hill City Water District Board as present. Matt Donkin seconded the motion. On roll call vote, all voted yes.

PLUMFIELD WATER DISTRICT - 2 APPOINTMENTS

Chairman Randall Crocker stated that the next item on the agenda are two appointments to the Plumfield Water District Board and he recommended Marty Gayer & Dave Bartoni be reappointed for another four year terms ending May 1, 2024.

Jack Warren made a motion to reappoint Marty Gayer & Dave Bartoni to the Plumfield Water District Board as present. Matt Donkin seconded the motion. On roll call vote, all voted yes.

SESSER FIRE PROTECTION DISTRICT - 1 APPOINTMENT

Chairman Randall Crocker stated that the next item on the agenda is an appointment to the Sesser Fire Protection District Board and he recommended Scott Ward be reappointed for another three year term ending April 30, 2023.

Jack Warren made a motion to reappoint Scott Ward to the Sesser Fire Protection District Board as present. Matt Donkin seconded the motion. On roll call vote, all voted yes.

COUNTY CLERK, COUNTY CORONER & SHERIFF

Chairman Randal Crocker stated the next item on the agenda are the monthly reports from the Franklin County Clerk, Franklin County Sheriff and Franklin County Coroner.

Ray Minor made a motion to approve all reports as presented. Alan Price seconded the motion. On roll call vote, all voted yes.
