As a part of our customer service, we have listed below a few recommendations to help protect your investment.

- If the edge of the asphalt is showing, rock/dirt should be placed next to the edge of pavement to prevent cracking.
- Keep grass from growing next to the edge of the asphalt because it can grow through the asphalt, weakening the mix
- Try not to drive vehicles or large equipment near or off the edge of the asphalt to prevent damage.
- Avoid turning vehicle wheels while vehicle is at rest on exceedingly hot days.
- Due to Southern Illinois having a high content of clay in the soils, cracking may occur on driveways and parking lots that were not constructed with full depth excavation and stone base during dry periods.
- Even with the use of crack control treatments to asphalt overlays some reflective cracking may occur.
- Add seal coat 2-3 years after paving, then every 3-5 years after that.

- 2 Provide IDOT approved HMA binder course, 2-1/4" nominal thickness
- 3 Provide IDOT approved HMA surface course, 1-1/2" nominal thickness

All material is guaranteed to be as specified. All work will be completed in a workmanlike manner according to standard practices. Any alteration or deviation from the above outlined work involving extra costs will be executed only upon written orders, and will become an extra charge over and above the quoted price. All agreements contingent upon strikes, accidents or delays beyond our control.
