MINUTES OF MEETING Oct 20, 2020

CALL TO ORDER

The Regular Meeting of the County Board, was called to order at 6:00 p.m. by Vice-Chairman Neil Hargis. This meeting was held in the former County Board room, Campbell Building, 901 Public Square, Benton, Illinois.

ROLL CALL

MEETING
