MINUTES: ****Franklin County Board Committee and Franklin County Board meetings were held in the former County Boardroom at Campbell Building, 901 Public Square, Benton. Those attending were asked to wear masks, and observe all social distancing guidelines. This will be the board's designated meeting location until further notice.

The meeting was called to order at 4:32 PM by Chairman John Gulley. See above list of those attending.

Chairman Gulley...

- Submitted the County claims which were approved and signed by all members present.
- Discussed the budget.....

Treasurer Steve Vercellino...

- Gave his report on the county finances, which included the possibility of restructuring 2 different bonds for the county. Both of these would also help with the upcoming budget. One of these would be combining the JDC, the Justice Center and the original loan for the Campbell Building. The interest rate would be lower and would make a big difference in repaying this loan. The same process could also be taken for the next draw on the loan for the courthouse. By taking the full amount that can be taken, it would be possible to pay part of the first draw and, again, lower the final amount to pay. Discussion followed.
- Reported that another \$62,000 was received for the JDC which brings the negative balance to around 370,000.
- Answered questions from several county board members concerning calls they had received about checks for real estate tax payments not clearing their banks in a timely manner.

State's Attorney Phillip Butler discussed the Anti-Crime Fund, in relationship to the county budget and the way the monies could be used. Discussion followed.

Supervisor of Assessments Cindy Loyd spoke on the new aerial needed for GIS. She has also talked to Eagle View and has information from them concerning their pricing. Discussion followed.

The meeting adjourned at 5:28 PM.







Coverage Map



MINUTES: **** Due to the Rise in Covid 19 Cases in Franklin County, the Committee Meetings were Available in Person or as Call-in Conference Meetings. Those attending in person were asked to wear masks, and observe all social distancing guidelines.

The meeting was called to order at 4:30 PM by Chairman John Gulley. See above list of those attending.

Chairman Gulley...

- Submitted the County claims which were approved and signed by all members present. Those who were on conference call only were advised to call the treasurer if there were any questions.
- Explained the item on the agenda concerning the \$2,910,000 General Obligation Bonds, Series 2012 (Justice Center). Discussion followed.
- Plans to send the entire 20-21 budget to the County Board members by the end of this week/first of next week. After discussion, it will be on the November 4th agenda to vote to post the budget and will then be voted on later that month. He also explained that with the possible refinancing, the budget could be a balanced budget and include a contingency line.

Treasurer Steve Vercellino...

- Gave his report on the county finances. Claims for this meeting total around \$252,000 and include several insurance payments and other uncommon expenses. One of which is an expense for "Vote By Mail" that will eventually be reimbursed. Discussion followed.
- Updated the information on the combining of 2 (Juvenile Detention Center and the first remodeling of the Campbell Building) debt certificates. This could result in lower rates and lower payments. This could also help balance the budget for 20-21. Discussion followed

Questions were raised on the back log in monthly reports which were a part of the prior audit concerns. Questions were also raised on the disbursement of real estate taxes to the different levy bodies. Discussion followed.

Supervisor of Assessments, Cindy Miklos, reported on the new aerial needed for GIS. She has spoken with Mike Rolla, County Highway, and Amos Abbott, 911. Each department is interested in helping with the cost. County Highway has committed to ¼ of the total cost for the fly-over. 911 will have the same amount (¼ of the total cost) on their next agenda for approval from the 911 Board. Contract will need to be signed by the end of this year.

The meeting adjourned at 5:14 PM.
