Ken-

I apologize again for not being at the meeting this coming Monday. My family and I will be on summer vacation.

Franklin County currently has the following debt:

- Bonds for Justice Center \$2,485,000 owed. This loan will be paid-off in December 2028
- Debt Certificates for Jail HVAC system & Campbell Building Roof \$160,000 owed. This loan will be paid off in October 2018.
- Loan from General County Fund to Special County Bridge Fund \$450,000 owed.

#### TOTAL CURRENT COUNTY DEBT - \$3,095,000

Under Illinois law, our debt limit is 2.875% of our equalized assessed value. Our current EAV is \$329,855,854. Therefore, our debt limit is approximately \$9.5 million. We are well under that limit.

If the county board chose to borrow \$1,000,000 at 3% interest over 20 years, the debt service would be about \$67,000 per year.

Approx. \$\frac{47}{5}, 5 \frac{84}{m0} + interest\$

If the county board chose to borrow \$500,000 at 3% interest over 20 years, the debt service would be

about \$33,000 per year.

Approx. # 2,750/mo +interest

There is a possibility that the county could seek a USDA public facilities loan at a lower interest rate.

If the county board chooses to borrow money, you would have to pay for the annual debt service by finding places to cut from the General Fund. As treasurer, I cannot recommend taking on an additional obligation of this size without identifying specifically how you will pay for it.
